- The presentation title in 12 words or less; think brief and catchy, yet descriptive of the topic.
- If the presentation is proposed for a conference track audience (Municipal, Commercial, Climbing, Utility), the general conference audience, a Field Day audience, or a Tree Academy audience.
- A brief description (200 word maximum) of the topic and proposed means of delivering information. The descriptive paragraph should contain a clear, but concise explanation of what participants will learn from the session, as well as how the presentation relates to the conference theme and its proposed track.
- A brief (25 word maximum) description of the main emphasis of the presentation, including learning outcomes. If your proposal is accepted, the description may be used in the conference program and in applying for continuing education credits (CEUs).
- Contact information for speaker(s) If there are multiple speakers, please designate one as the primary contact.
  - o name(s), titles, and company name or agency
  - o email and mailing address(es)
  - o phone number(s)
- A complete professional biography for each speaker. Biographies will be used to apply for CEUs. PNW-ISA reserves
  the right to edit biographies for promotional purposes.
- A high-resolution headshot photograph for each speaker.
- If your participation is contingent on a speaking fee or expenses being covered (knowing costs helps us with our program planning).
