JOB SUMMARY:

In collaboration with the Manager of FSHP, the Occupational Therapist is responsible for the ongoing development, implementation and evaluation of occupational therapy; holistic client-centered activities that aid in the acquisition of life skills and resources needed to be successful in community living. The Occupational Therapist will use evidence-based tools for functional assessments\interventions and work collaboratively with a multi-disciplinary team. The Occupational Therapist will coordinate, develop and lead different agency wide initiative.

QUALIFICATIONS:

- Bachelor's degree in Occupational Therapy, Psychoeducation, or a related field.
- Two years experience working with clients recovering from mental illness.
- Experience with Forensic Mental Health is an asset.

RESPONSIBILITIES:

Be an essential part of the client's circle of care

- Participate in case conferences and meetings as needed.
- Carry a client caseload and provide coverage to other team members as needed.
- Meet clients in an office setting and in the community as required.
- Communicate efficiently with the treatment team.
- Follow protocols regarding risk management.

Intervention & programming

- Based on client-identified needs and goals, develop and implement intervention strategies with individual clients and client groups (planning, organizing, animating) within the Forensic Supportive Housing Program (FSHP) and within the wider agency.
- Provide consultation to Salus colleagues to develop and implement client intervention strategies (e.g. skill teaching).
- Provide client individualized skill teaching, in collaboration with case managers.
- Access needed resources (memory devices, equipment for ADL etc.) for clients.
- Advocacy at a system level for needed resources.
- Assist in the transfer of skills to a new environment.

Provide group activities as part of the Forensic Supportive Housing Program

- Offer activities based on client interest and needs.
- Elicit client feedback on the effectiveness of the activities.
- Facilitate groups at Head office or in the community for the FSHP clients and other Salus clients.

<u>Network with OT colleagues working in the mental health system and other mental health</u> <u>professionals</u>

- Work closely with Salus' Fisher based OT as needed.
- Attend community network meetings.
- Attend workshops and conferences.
- Participate in meetings and training opportunities initiated and provided by universities.
- Supervise student placements.

Participating in ongoing evaluation and enhancement of the FSHP

- Use appropriate assessment tools to identify clients baseline at program entry.
- Coordinate and support the forensic programs evaluation plan (implementation and impact).
- Provide support and mentoring to teammates with individual measure instruments.
- Fine tune program materials within a recovery model framework.
- Ensure that all program information is reviewed and updated with client and staff input.
- Participate in program reviews.
- Assist in developing evaluation tools.

Fulfilling team and other responsibilities

- Work collaboratively and cooperatively with team members.
- Coordinate and train staff on the data collection program (e.g., EMHWare).
- Attend regular team meetings and administrative meetings.
- Provide feedback, advice and guidance to the forensic teams in the areas of behavioural management and teaching/coaching strategies.
- Orient staff to the role of Occupational Therapist.
- Take direction from the Program Manager on tasks to be accomplished.
- Participate in organizational committee work.
- Other duties may be assigned by the manager, as needed.

SUITABILITY FACTORS:

- Displays values and attitudes in keeping with the social service professions.
- Demonstrates sound judgement and common sense in decision-making and in professional approaches to the work.
- Demonstrates an ability to work in a team as well as an ability to take independent action and initiative in the job.
- Shows a commitment to work.
- Demonstrates creativity and intelligence.
- Manages stress related to work environment.

KNOWLEDGE:

- Demonstrates specific knowledge of health issues and of social problems associated with psychiatric disabilities and the impact of mental illness on functional capacity and family dynamics.
- Demonstrates knowledge of Occupational Therapy assessment tools and their application in the field of Mental Health.
- Demonstrates knowledge of the forensic mental health system and the individuals that are impacted by it.
- Has knowledge of Group Dynamics theory and practice;
- Has mastery of principles of Client-Centred practices;
- Has a solid understanding of Concurrent disorders and best practices to support clients living with such issues.

- Has knowledge in structuring and leading program evaluation.
- Demonstrates understanding of:
 - Crisis intervention and prevention;
 - Suicide prevention and intervention;

SKILLS:

- Ability to evaluate learning capacity and identify behavioural problems.
- Ability to perform an occupational therapy assessment.
- Ability to develop therapeutic programs.
- Ability to establish supportive relationships.
- Ability to establish a balance between recovery-led work and risk management and monitoring requirements.
- Ability to develop together clients' recovery based plans based on needs and goals.
- Teaching and coaching skills.
- Ability to work collaboratively in a multi-disciplinary team.

LANGUAGE REQUIREMENT:

- Bilingualism (French/English) is essential to the position. The candidate must be able to speak and write proficiently in both languages.
- Fluency in additional languages is an asset.
