Dialogue for Peaceful Change (DPC) is an international program that has brought together the best methodologies from around the world in community based conflict mediation, providing effective tools and strategies for analyzing and addressing conflicts.

This is a program applicable to conflicts and disputes in communities, families and organizations moving beyond traditional mediative methods, focusing on conflict content, culture and spirituality.

The experiential processes allow practice of the stages of conflict mediation and to apply the tools of "meditative behavior" in a realistic context. Participants receive international accreditation as DPC Facilitators upon completion.

Following last year's success at the first **Open Forest Day (OFD)** that attracted more than 600 participants, and over 30 organizations, and positive feedback from partners; the Private Lands Stewardship and Outreach (PLSO) Section of NSDNR will be hosting another OFD event this summer; at **Shubie Park**, **on June 25**.

As in 2015, the main purpose of the 2016 event for Natural Resources would be to educate the general public about various options available to them concerning woodland management, and the important role natural resources play in our economy, the environment, and our health. Also in keeping with the goals and actions of the Natural Resources Strategy (The Path We Share), DNR wishes to work more closely with woodland owner organizations across the province and provide collective support to landowners.

- To share knowledge about the importance of sustainable development of natural resources;
- To increase public awareness of natural resource stewardship initiatives and services available to woodland owners and the general public;
- To increase public confidence in natural resource management;
- To provide opportunity to engage the public; and
- To increase awareness of the importance of the forest sector in Nova Scotia.
- To build and strengthen relationships with land owner organizations
- To build and strengthen relationship with organizations that work in natural resource environments
- To provide an opportunity for urban residents to enjoy the outdoors and connect with nature

Nova Scotians, Not Oil Industry, Should Decide Offshore Development

Lunenburg, 8 June, 2016 – The South Shore Chapter of the Council of Canadians announces the launch of a new campaign to ensure Nova Scotians have a far greater voice in decisions regarding developments in our offshore waters.

"World Oceans Day is the ideal moment to advocate a more democratic process for deciding what happens in Nova Scotia's marine environment," says Marion Moore, Co-chair of the Chapter and member of the coordinating committee for the Campaign to Protect Offshore Nova Scotia (CPONS).

Today, the Canada/Nova Scotia Offshore Petroleum Board (CNSOPB), the federal/provincial agency that licenses and regulates oil industry activity offshore, is made up largely of oil industry veterans. Recently, the CNSOPB approved licenses for Shell Oil and Norway's Statoil to drill exploratory oil wells adjacent to the province's most important fishing grounds, in a fragile marine environment. Many see those decisions as unwise or argue that the conditions imposed by the agency do not adequately reflect the risks involved. The lack of informed public involvement in the CNSOPB decisions is also striking.

The waters in question are a critical part of the province's biosphere. They are the nursery of a sustainable fishery, the main attraction for our tourism industry, and the lifeblood for thousands of Nova Scotians who live and work along this coastline.

"How can a body dominated by the oil industry decide what is an acceptable risk to our marine ecology and to traditional industries that contribute billions of dollars every year to our communities?" asks Marilyn Keddy, CPONS coordinating committee member.

"It's time to replace the CNSOPB with an agency where the communities most affected and independent experts hold the majority."

In addition to a more democratic CNSOPB, CPONS is calling for:

- mandatory public hearings on all major developments in the offshore, with independent expert witnesses and funded public interest legal representation
- transparent decision-making and reporting by the agency
- stronger in-house research capacity, and
- a moratorium on oil drilling in all zones of critical importance to marine ecosystems, or of particular importance to the fishery.

"If there's an argument for not subjecting vital decisions about the offshore to community control we'd like to hear it," says Moore.

McGill University Understanding Game-Based Approaches for Improving Sustainable Water Governance Dear sir or madam,

Is the protection of Canada's freshwater resources a concern for you? If you were in charge would you do things differently?

McGill University is planning an event in Halifax where interested stakeholders can participate in a simulation gaming event that puts them in charge. Participants will play a game called Aqua Republica developed by the United Nations Environmental Program in partnership with DHI. This event will be part of the UpSWinG (Understanding Game-Based Approaches for Improving Sustainable Water Governance) initiative, a partnership between McGill, the University of Waterloo, Wageningen University (The Netherlands), the DHI group and Signature Games. For more information please refer to this website: www.gamingthewatersystem.org Players act as members of the planning committee for the fictional country of Aqua Republica. They must manage their resources and their development goals while still maintaining the ecosystem. The game is powered by scientific models and is updated after every turn based on your choices.

This event will give you an opportunity to connect with other interested stakeholders in the area and will give you further insight into the difficulties of managing a watershed. It's also a lot of fun!

The event will take roughly 3 hours and we will likely hold two sessions throughout the day in order to accommodate as many people as are interested. We will provide snacks during the event and do everything we can to ensure a pleasant, enjoyable and insightful event.
